MANDATED REPORTING

IT IS YOUR RESPONSIBILITY TO REPORT IT

MCA 41-3-201 thru 209 Reporting Child Abuse (excerpt)

Persons responsible for a child's welfare: child's parent, guardian, foster parent, an adult who resides in the same home in which the child resides, persons providing care in a day-care facility, employee of a public or private residential institution, facility, home, or agency, or any other person responsible for the child's welfare...

MANDATORY REPORTERS: When professionals and officials listed...know or have reasonable cause to suspect...that a child is abused or neglected...they shall report the matter promptly.

Physician, resident, intern, member of hospital staff engaged in the admission, examination, care, or treatment of child, nurse, osteopath, chiropractor, podiatrist, medical examiner, coroner, dentist, optometrist, any...health or mental health professional, religious healers, school teachers, other school officials, employees who work during regular school hours, social worker, operator or employee of any registered or licensed day-care or substitute care facility, staff of a resource and referral grant program organized under 52-2-711 or of a child and adult food care program, an operator or employee of a child-care facility, foster care, residential, or institutional worker, peace officer or other law enforcement official, member of the clergy, guardian ad litem or a court-appointed advocate..., employee of an entity that provides direct services to children.

SCHOOL STAFF - Reporting concerns to another school official does not satisfy the reporting requirement. School personnel must report directly to the Child and Family Services Division Hotline. Where there is a conflict between state law and a school's reporting procedures, state law prevails.

Thousands of children are alive and safe today because a principal, teacher, or some other caring adult was sensitive to a child's behavior and acted on that information by filing a report.

Reporting, by itself, does not guarantee a child will be protected from continued abuse; but the failure to report adds yet another layer of betrayal to the suffering of an already betrayed child.
